Funding for Fees, Health Insurance, and Non-resident Tuition for GSRs

If a GSR is employed exclusively on research grants at a total of 25% or more for the quarter, the grants will pay all of the Fees, Health Insurance, and Non-Resident Tuition. If the appointment is split between two or more research grants, the charges are prorated between the grants. If the GSR's total appointment is less than 25%, none of the charges are paid by the grants.

Funding for Fees and Health Insurance for GSR/TA split

If a GSR has a 25% GSR/25% TA appointment, the Health Insurance and Fees will be split between the two FOAPALs paying for the GSR and TA appointments.

Funding for Non-resident Tuition FOR GSR/TA split

GSR appointments pay all of the non-resident tuition charges when the GSR is employed at 25% or more on the grant. If a student is less than a 25% GSR, the student must pay their own nonresident tuition. When split 25% GSR and 25% TA the GSR appointment will pay half of the NRST and the Department will pick up the remainder.

GSR NRST Incentive Program

Beginning in year 2014-15, the Graduate Division will pay 75% of the Non-resident tuition for the first year the graduate student is supported by GSR. The program will expand over the next two years to cover first, second and third year students in the same manner.

**Non-resident tuition waiver for GSRs advanced to candidacy has a 3 year time limit; after 3 years, the non-resident tuition charge is reinstated.
